3. Will not be eligible to hold moorage or have access to the moorage basin.
4. Have attained their nineteenth (19) birthday.
5. Shall be entitled to all Clubhouse privileges including use of a minimum house account and signing authority.
6. Will pay an initiation fee.
7. Should the Social Member want to upgrade to Regular Member status they would pay the difference between the Social Member initiation fee paid and the then current Regular Member initiation fee.
8. Will be responsible for all other dues and fees.
9. May have spousal privileges.
10. Shall be responsible and accountable for the actions of their guests

All applications for membership shall be proposed and seconded by two (2) society members in good standing. The Board shall then consider such applications for membership at its next regularly scheduled meeting and the decision of the Board shall be final and binding. The Board shall not be bound to provide the reasons for refusing membership; however, it may do so at its own discretion.
