5. May have spousal privileges or common law privileges.
6. Shall be responsible and accountable for the actions of their guests.
7. Shall be entitled to hold office or vote at any annual general meeting or extra ordinary general meeting of the society, in person or as represented by proxy.
8. A minimum house account will apply.
