

SKIPPER GUIDELINES

As the Skipper of your vessel, ensuring your safety and the safety of your crew is important. As we return to sailing during COVID-19, it is equally important that we play a continued role in keeping our community safe. In order for you to return to the sailing program, you will be required to agree to the following:

- I will stay informed, be prepared and follow all public health advice, guidelines and mandates.
- I will practice good hygiene.
- I will not come to the Club or enter the basin if I am feeling ill or showing any symptoms of illness no matter how minor, with no exceptions.
- I will not come to the Club or enter the basin if I have been in contact with someone who is feeling ill or showing symptoms of illness no matter how minor, with no exceptions.
- I will make necessary contacts safer with appropriate controls.
- I will ensure there is increased cleaning of frequently touched surfaces.
- I will consider the use of non-medical masks in situations where physical distancing cannot be maintained
- I will not come to the Club if I have travelled or have been in contact with someone who has travelled outside of Canada or in an area under a travel advisory in the last 14 days.
- I will ensure only persons who are free of symptoms of illness no matter how minor for 14 days are able to participate as Crew on my vessel.
- I will continue to practice appropriate social distancing in the foreshore area and in the basin.
- I will ensure my vessel is properly cleaned before and after each use.
- I understand that the allowed number of crew must not exceed 6.
- I understand I am responsible for the spacing of crew on my vessel in accordance with the requirements of their positions and can institute wearing of masks if distancing is a challenge.
- I understand I am responsible to ensure that my vessel can be handled safely and if this cannot be done, then my vessel will not be raced.
- I have read, understand and agree to the Kelowna Yacht Club's Safety Plan (<https://kelownayachtclub.com/wp-content/uploads/COVID-19-Safety-Plan.pdf>).
- I represent and warrant to the Kelowna Yacht Club that I have not been advised by the Government of Canada, Interior Health or my doctor to self-isolate due to possible exposure to COVID-19.
- I will adhere to all posted signage and social distancing measures put in place while on Kelowna Yacht Club premises.
- I acknowledge that there are risks associated with entering Club facilities and/or participating in activities within the Club, and that measures taken by the Club and participants, including those set out above and in the Kelowna Yacht Club Safety Plan, will not entirely eliminate those risks.
- I will maintain a log of those who are on my vessel each week for contact tracing purposes.
- I will ensure I perform a *Pre-Race COVID-19 Skipper Checklist* with my crew prior to each race.
